

Netiquette ECCV 2024

Introduction

This netiquette is specifically designed for business partners of the ECCV 2024. Its purpose is to ensure that the use of social media in relation to ECCV 2024 is aligned with legal and ethical values and guidelines.

Scope of Application

This netiquette applies to all external partners, including suppliers, distributors, affiliates, and any other entity that has a business relationship with ECCV 2024.

Guiding principles

Consistency with ECCV 2024 Values: All social media activities related to ECCV 2024 must reflect the core values and ethics of ECCV 2024.

Compliance with regulations: All social media activities related to ECCV 2024 comply with all applicable laws and social media regulations in all operating jurisdictions.

Confidentiality: External partners, including suppliers, distributors, affiliates, and any other entity that has a business relationship with ECCV 2024, shall maintain the confidentiality of sensitive or confidential information obtained through the partnership.

Use of Social Media

Identification: When discussing products or services related to ECCV 2024, clarify the nature of the relationship with ECCV 2024.

Content: Ensure that all content posted is accurate, not misleading, and consistent with the image of ECCV 2024.

ECCV 2024 reserves the right to remove any post that does not comply with the following rules without giving reasons.

In particular, the following are not permitted:

- offensive, racist, discriminatory, sexist, pornographic, defamatory, illegal, misleading or inciting to violence;
- content that is indecent or unsuitable for minors;
- content that does not respect the privacy of others;
- verbal aggression;



- spamming;
- activities that may adversely affect the proper functioning of social media, including uploading documents that may contain viruses;
- content that is contrary to the interests of ECCV 2024.

Interaction: Promote positive and constructive dialogue and avoid any form of communication that may be defamatory or harmful to ECCV 2024 or third parties.

ECCV 2024 reserves the right to remove comments that do not comply with the following rules without giving reasons. In particular, the following are not permitted:

- comments that are not relevant to the post;
- comments that do not respect the opinion of other users;
- comments that are inaccurate, non-objective and contain illegal content.
